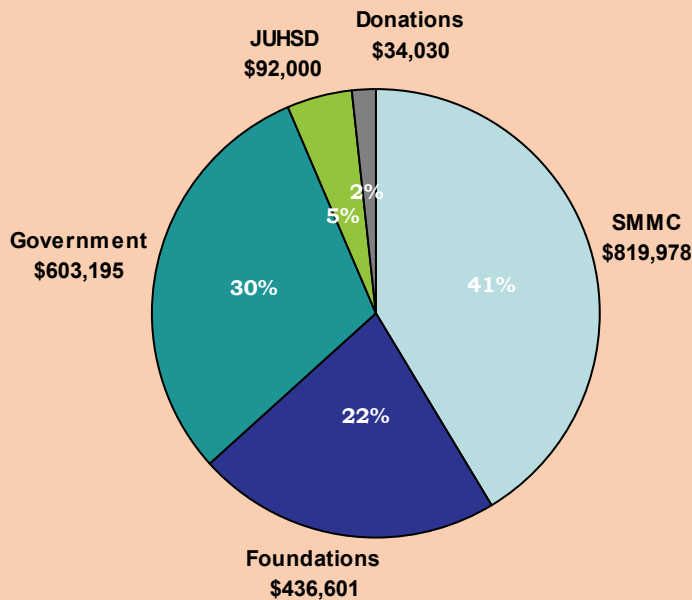

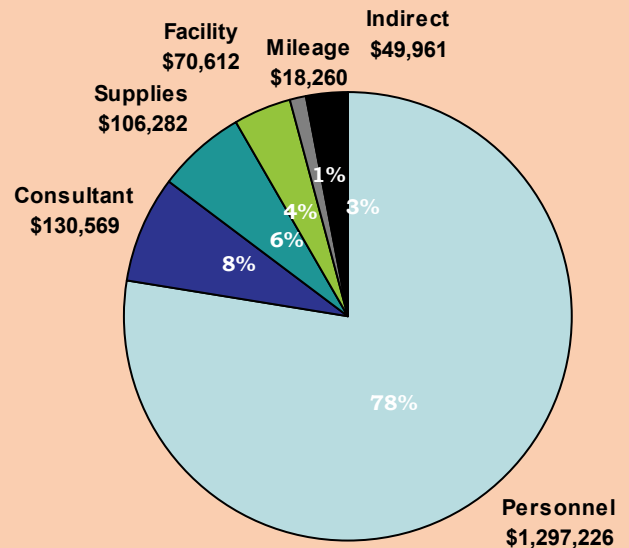
Revenue and Expenses July 2008 - June 2009
